All fees must accompany the Industrial Affiliate Application. Refunds will not be issued.** Payment is to be made **only in U.S. dollars** and **must** be through a U.S. bank or correspondent within the U.S. Payment may be made by check, money order or by credit card (MC or VISA). Bank checks must have complete numeric coding to avoid collection fees.

Claims for damaged or missing journals must be placed within four months after date of mailing within in the U.S.A. and within six months after date of mailing to outside of the U.S.A.
