



Liability/Indemnity Certificate Requirements

Our insurance carriers require that a certificate of insurance be provided directly by your insurance agent. All sections must be completed as done in the example and in English.

A certificate of insurance for no less than \$1,000,000 must be provided to the American Society for Enology and Viticulture no later than April 28, 2006.

This certificate will name the **American Society for Enology and Viticulture and the Sacramento Convention Center** as additional insured.

If you plan to pour wine samples in your booth, you will need to add "Host Liquor Liability" in the General Liability section of the certificate.

If a contract is signed after April 28, 2006, then the certificate must be provided with contract and full payment of booth fees.

These requirements are per your contract terms.
